Therefore, the course interest form will allow us to keep in touch with you and track our potential enrollment for each academy. Please keep in mind that course dates are subject to change and possible cancelation due to low enrollment. If you have completed an interest form at this point, do not complete an additional one.</i></p>			
Step 2:	<p>This will be a <u>challenging and time-consuming class</u>, using an accelerated scheduling format. Classes are a 40-hour week, MTWTH, 0600-0715 hours for KINES 1.34 class (Boot Camp) and FIRCT 590 for Tower Drills and Friday, 0800-1700. <u>The required 80% academic standard for the Firefighter I Academy is rigorous.</u> Candidates need to be aware at the outset that this will place extraordinary demands on them physically and emotionally. Time management will also be critical. Additional Saturdays may be available for EMT tutoring.</p> <p><b>Monday, August 31, 2020:</b> Application packets will be available on-line. The medical clearance is required to provide reasonable assurance that there is no medical reason why you should not participate in the program. And, medical clearance must be obtained at your own expense. <u>This clearance needs to be 6-months current.</u></p> <p><b><u>REQUIRED APPLICATION FORMS:</u></b></p> <ol style="list-style-type: none"> <li>1. <a href="#">Health/History Statement &amp; Par-Q</a> (complete prior to seeing your physician). Note: not all insurances will cover a physical. This fee may be expected at the time you are seen by the physician and can vary in cost.</li> <li>2. <p><b>EMT Certification:</b></p> <p><b>More information will be given to you by the EMT Instructor. You should be prepared to perform the below tasks, which include fees:</b></p> <ul style="list-style-type: none"> <li>• A student must be 18 years old by <b>January 2021</b> to participate in the Fire Academy per National Registry/EMT requirements.</li> </ul> <p><b>Clinical Hospital/Ambulance Hours Within the Academy:</b> <i><b>DO NOT</b> perform the below tasks until told to do so or you will have to do it again.</i></p> <p>Please be aware that you will need to have a 10-Panel Drug Test ONLY from Fremont-Rideout Occupational Health or you will not be allowed to do your clinical hours in the hospital. These tests must be obtained at your own expense. You will also have to have a criminal background check. Both items will be scheduled by your instructor (TBA) and <b>are not pre-requisites</b>. These requirements are date sensitive-background check and drug screen.</p> <p>After successful completion of your EMT training you need to be aware of the following: <b>National Registry Application for National Registry Exam (<a href="http://www.nremt.org">www.nremt.org</a>):</b></p> <ol style="list-style-type: none"> <li>1) Successfully complete the EMT course (2 years current);</li> <li>2) Non-expired CPR credential for health care providers;</li> <li>3) Create login, pay fees, pass the exam</li> </ol> <p><b>Sierra-Sacramento Valley – E.M.S. Application (<a href="http://www.ssvems.com">www.ssvems.com</a>):</b> A student cannot work in the Sierra-Sacramento area without this certification and will apply and test for SSV-EMS <u>after</u> successfully completing the NREMT process (or any county agency).</p> <ol style="list-style-type: none"> <li>1) Student must complete a criminal history background check (both state and federal) as specified in Article 4, Chapter 10 of the EMT Initial Certification Requirements</li> <li>2) Complete application, pay fees, pass the exam             <ul style="list-style-type: none"> <li>• <i>A student can still complete the academy by successfully passing the EMT learning domain but not apply for EMT status with NREMT and SSV-EMS (or other applicable agencies). The medical clearance will be required prior to **December 5, 2020**. Schedule your appointment accordingly but do not obtain clearance until advised to do so. Please provide any changes to your email or physical address to the Public Safety Department.

Public Safety Staff will do the following once packets are received, reviewed & approved:

Knowing the criteria, in advance, will alleviate confusion when you complete your requirements.</p>	
<b>Certification</b>	<p>Upon successful completion of the Academy, students will meet the 2013 training requirements for the California State Fire Marshal Firefighter I. A student will then be able to apply for the Certification after successful completion of the task book and experience requirements, one year as a volunteer or reserve firefighter or six months as an intern/full time paid firefighter with a California fire department. The California State Fire Marshal's Office has completed the National accredited certification process, approved by the Internal Fire Service Accreditation Congress (IFSAC) and the National Board on Fire Service Professional Qualifications (Pro Board). A student completing the Academy will be eligible to apply for these additional certifications. <b>Students will also receive the following State Fire Training certificates: Confined Space Awareness, Hazardous Materials First Responder/DECON (CSTI), Fire Control 3B, Firefighter Survival, Vehicle Extrication, and California Wildland Suppression and Cal- Fire Basic Wildland Firefighter certificates.</b></p> <p>The EMT (Emergency Medical Technician) course consist of 170 hours; which includes 156 hours of didactic (lecture) and practical skills lab, and 24 hours of clinical experiences. The curriculum is in compliance with the US DOT (Department of Transportation), the National Registry of Emergency Medical Technician (NREMT), the California State EMS Authority, and the Sierra Sacramento Valley EMS agency.</p>
