2017-18 Board of Governors (BOG) Fee Waiver Application Instructions

BOG FEE WAIVER ELIGIBILITY CRITERIA

The BOG Fee Waiver waives enrollment and student service fees, if eligible. It may also waive a portion of the semester parking permit fee for the fall and spring terms. The BOG Fee Waiver does not provide assistance for books, supplies or other costs.

- Must be a California resident, an eligible AB 540 or AB 1899 student **and**
- Meet **one** of the following income eligibility criteria (Method A, B or C) listed below.
- **Important:** Effective Fall 2016 eligible students must meet academic and progress standards in order to avoid losing their BOG eligibility. For additional information, contact the Financial Aid Office.

METHOD A / SPECIAL CLASSIFICATION – If you are eligible based on one of the criteria below, you are required to provide one of the documents listed below:

TANF/General Assistance

- Notice of Action
- Welfare to Work Plan
- Printout of Passport to Services

SSI/SSP

- Certification from Social Security Administration
- Current bank statement showing the SSI direct

Special Classification

- Dependent of Disabled Veteran
- Recipient or child of a recipient of the Congressional Medal of Honor
- Dependent of a victim of the 9/11/01 terrorist attack
- Dependent of a deceased law enforcement/ fire suppression personnel

METHOD B – Eligibility is based on household size and total family income earned/received in **2015**.

- **DEPENDENT Student:** Eligibility is based on parent(s) total 2015 taxed and untaxed income.
- **INDEPENDENT Student:** Eligibility is based on student and spouse's (if married) total 2015 taxed and untaxed income.

HOW TO APPLY FOR METHOD A OR B

- Complete the online BOG Fee Waiver application at <http://www.yccd.edu/educational-services/bog.aspx>. Click on the link **For Yuba College Students** or **For Woodland Community College Students**. You will complete the online BOG Fee Waiver application through CCCApply.
- Download the paper application at MyCampus Portal. Complete the application and submit to the Financial Aid Office.
- Complete the 2017-2018 FAFSA application online at www.fafsa.gov or the Dream Act application at www.csac.ca.gov/dream_act.asp.

METHOD C – Eligibility is based on your 2017-2018 FAFSA or Dream Act application.

- Eligibility is based on your Cost of Attendance (COA), Expected Family Contribution (EFC) and financial need.
- Your COA is based on the housing plan you reported on your FAFSA/Dream Act application. Your EFC is listed on your Student Aid Report.
 - **Living with Parents: 12,599**
 - **Military - Living with Parents: 11,550**
 - **Living Off Campus: 20,510**
 - **Military - Living Off Campus: 11,240**
- Financial need is calculated as follows: COA less your EFC = Financial Need. The financial need must be \$1,104 or greater to qualify for a Method C BOG Fee Waiver.

IMPLEMENTATION OF Assembly Bill 1899: Victims of Trafficking, Domestic Violence and other Serious Crimes

AB 1899, chaptered in September of 2012, provides for a non-resident enrollment fee exemption for "Victims of trafficking, domestic violence and other serious crimes". In addition, the legislation allows these students to apply for and, if eligible, receive financial aid from programs administered by public postsecondary institutions or the state of California. Finally, the legislation provides that enrollment fees shall be waived for these students who apply for and are eligible to receive Board of Governor enrollment fee waivers.

*This **FEE WAIVER** application is for California residents, eligible AB 540 students, and eligible AB 1899 students, as determined by the Admissions or Registrar's Office, and for homeless youth as determined by the Financial Aid Office. If you have not had your California residency or eligibility status determined by the Admissions or the Registrar or homeless status determined by the Financial Aid Office, see one of those offices to obtain the determination. Fee waiver eligibility cannot be determined until your status has been verified.*

IMPLEMENTATION OF THE CALIFORNIA DOMESTIC PARTNER RIGHTS AND RESPONSIBILITIES ACT

The California Domestic Partner Rights and Responsibilities Act extends rights, benefits, responsibilities and obligations to individuals in domestic partnerships registered with the California Secretary of State under Section 297 of the Family Code. If **you** are in a Registered Domestic Partnership (RDP), or legal same sex marriage, you will be treated as an Independent married student to determine Enrollment Fee Waiver eligibility and will need to provide income and household information for your domestic partner. If you are a dependent student and your parent is in a Registered Domestic Partnership, or legal same sex marriage, you will be treated the same as a student with married parents and income and household information will be required for the parent's domestic partner.

Note: These provisions apply to state student financial aid ONLY, and not to federal student financial aid.
